18.50 LARGE POWER – TRANSMISSION VOLTAGE RATE

AVAILABILITY

Available to all members of the Association.

TYPE OF SERVICE

Three phase, 60 hertz, at 115,000 volts or greater.

RATE PER MONTH

Demand Rate Components:

Kilowatt (kW) Demand per month: \$30.77 per kilowatt during the Peak Period

Peak Period Demand: The member's Peak Period Demand will be based on the maximum 30-minute integrated kW demand established by the member during the Peak Period as recorded by a demand meter during the Association's coincident peak period from 1:00 p.m. through 9:00 p.m., Monday through Saturday, with the exception of New Year's Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day, and Christmas Day.

Energy Rate Component: \$0.03628 (36.28 mills) per kilowatt-hour

MINIMUM MONTHLY BILLING CHARGE

The minimum monthly billing charge shall be the greatest of the following charges as determined for the member in question:

1. The minimum charge specified in the contract of service;
2. A charge of: \$750.00

CONDITIONS OF SERVICE

1. The member will comply with and be bound by the Association's lawful rules, regulations, and By-laws as the same may be amended from time to time.
2. Any additional charge imposed upon the Association by Tri-State due to the Member's failure to so maintain the power factor maintain a power factor at the Point of Delivery between ninety-five percent (95%) lagging and ninety-five percent (95%) leading at the Point of Delivery will be passed on to the Member.

3. Any extraordinary charges, related to transmission service by others or unusual load characteristics levied by the Association's power supplier as a requirement to provide service to a load qualifying for this rate, will be passed on to the member.
4. The Generation Demand Charge, the Transmission Demand Charge, and the Energy Charge will be adjusted to coincide with Tri-State's wholesale rates charged to the Association.

TERMS OF PAYMENT

The above rates are net, due and payable on or before the date stated on the bill. If not paid on or before this date, a late charge of 2% per month or \$5.00 per month whichever is greater will apply; service will be discontinued as determined by Rules and Regulations 12.0 Discontinuance of Service.

TAXES, FEES, ETC.

Any franchise fee, or any other similar tax or fee, however denominated, shall be recovered by a surcharge only upon those members receiving service within the boundaries of the municipality imposing such tax or fee.
