General Rules and Regulations

17.11 IRRIGATION RATE

AVAILABILITY

Available to all members of the Association for irrigation purposes only, upon the execution of a written service contract for such service.

TYPE OF SERVICE

Single-phase and three-phase where available, at available voltages.

RATES AND CHARGES

Single-Phase Grid Access, per year	\$158.00
Three-Phase Grid Access, per year	\$247.40
Energy, per kWh	\$0.13366
Horsepower Charge, per horsepower, per month	\$3.00
Demand, per kVA	\$2.00
Power Cost Adjustment	\$0.00

*Excluded holidays: New Year's Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day, and Christmas Day

Single-Phase Minimum Monthly Charge per Meter	\$13.16
Three-Phase Minimum Monthly Charge per Meter	\$20.61

CONTRACT PERIOD

All contracts entered into because of new construction or rebuilding of existing service will be for a minimum period of one (1) year. The contract may be assumed by another member, but such assumption will not relieve the original member of the responsibility of completing the payments for such original one-year period. After the original one-year contract has been fulfilled, all subsequent periods will be for a minimum of a one (1) year period.

DETERMINATION OF BILLING DEMAND

The billing demand will be the maximum 15-minute integrated kVA demand established by the member during the billing period as indicated or recorded by a demand meter.

DETERMINATION OF HORSEPOWER

The contract horsepower will be the combined nameplate rating of the installed motors or the historical metered kVA demand, whichever is greater.

The determination of the metered kVA demand will be the maximum 15-minute integrated kVA demand as indicated or recorded by a demand meter.

CONDITIONS OF SERVICE

The rated capacity of single-phase motors will not be in excess of ten horsepower (10 hp) unless written approval is received from the cooperative.

Normally, motors having a rated capacity in excess of ten horsepower (10 hp) must be three-phase.

IRRIGATION SEASON

The season will be the April billing month through the March billing month.

ANNUAL GRID ACCESS CHARGE

The annual grid access charge will be split into twelve (12) monthly payments. Members may request to pay the full amount up front. Any account disconnected during the season will be required to pay the Association any unpaid balance of the annual grid access charge.

Any account that has a past due balance from the previous season will be required to pay in full said previous season delinquent charges plus the current season annual grid access charge up front before service will be reconnected.

TERMS OF PAYMENT

The above rates are net, due, and payable on or before the date stated on the bill. If not paid on or before this date, a late charge of 2% per month or \$5.00 per month, whichever is greater, will apply; service will be discontinued as determined by Rules and Regulations 12.0 Discontinuance of Service.

TAXES, FEES, ETC.

Any tax, franchise fee, or other similar charge, however denominated, will be recovered by a surcharge only upon those members receiving service within the boundaries of the district and/or municipality imposing such tax or fee.
